I appreciate your effort each and every day and look forward to raising the bar again in 2006.









Benefits Food Pyramid Takes On A Totally New Shape

The Center for Nutrition Policy and Promotion (an organization of the U.S. Department of Agriculture) has released the interactive MyPyramid food guidance system (www.mypyramid.gov). The familiar shape is now updated to provide a more individual approach to eating for good health. The new pyramid can provide recommended servings for each food group, based on an individual's weight, gender, activity level and age.

The new food pyramid promotes consuming adequate nutrients within individual calorie needs. It also emphasizes whole grains and adequate portions. Instead of using the generic "serving" to advise Americans on healthy portions of food, the new food pyramid uses real measurements like ounces and cups. And of course, including physical activity is a necessary complement to any healthy eating plan.

The new food pyramid Web site at www.mypyramid.gov includes more specific guidelines on:



- Fats
- Carbohydrates
- Sodium
- Potassium
- Alcohol

Try these features at mypyramid.gov for yourself. Supply the MyPyramid plan with age, gender and activity level to help determine the right amounts and types of food to fit your personal healthy eating plan. MyPyramid Tracker provides a detailed assessment of current diet and physical activity. The history function allows you to track your progress over time. SPICY SALMON STEAKS WITH TARRAGON SAUCE

Even if fish isn't your favorite – or you just don't like it – this will make a believer out of you! Absolutely delicious and easy to prepare!

¹/₄ cup dry white wine ¹/₄ cup white wine vinegar
1 garlic clove, peeled and softened
3 T. Dijon mustard
2 tsp. fresh lemon juice
¹/₂ tsp. coarsely ground black pepper

4 (4-ounce) salmon steaks, about 1 inch thick2 T. plus 2 tsp. reduced calorie

mayonnaise

1-2 T. minced fresh tarragon, to taste

Combine wine, vinegar and garlic in small saucepan. Boil over high heat until liquid is reduced by half. Discard garlic; whisk in mustard, lemon juice and pepper. Set 1 T. aside. Let remaining wine mixture cool; then place in zip-close plastic bag. Add salmon steaks, squeeze out air and seal bag. Coat the salmon by turning bag back and forth. Let salmon marinate for 10 minutes. Spray grill with non-stick spray and grill over medium fire until done. For Tarragon Sauce: Whisk together reserved 1 T. wine mixture, mayonnaise and tarragon in a small bowl. Set aside. Grill steaks about 5 minutes on each side. Serve with tarragon sauce.

HERBED BEEF BURGERS

A slice of juicy tomato and a crisp lettuce leaf are all you need to top this mouth-watering burger!

- 2 1-ounce slices of whole wheat bread
- 1 pound ground very lean beef
- $\frac{1}{3}$ cup minced flat-leaf parsley
- 2 T. freshly grated Parmesan cheese
- 3 garlic cloves, minced
- 1 tsp. dried basil
- ¹/₂ tsp. freshly ground pepper
- ¹/₄ tsp. salt
- 4 (1 ounce) hard rolls, split

Place bread in blender or food processor and pulse to a fine crumb. Combine all ingredients in large bowl and shape into 4 equal patties. Grill on rack (pre-sprayed with non-stick) until an instant - read thermometer inserted in the side of each patty reads 160° F for medium, about 5 minutes on each side. Serve each burger in a hard roll. A grilling favorite, with a few special touches added for extra flavor.
